### 1. General Information

#### How is data collected?

## **4. Data Collection on My Website**

#### **4.1. Cookies:**

Cookies from service providers are used for the functionality of the website. Upon visiting my website, you can decide which cookies you wish to accept. A selection prompt is displayed automatically.

#### **4.2. Server Log Files:**

The website provider automatically collects and stores information in so-called server log files, which your browser automatically transmits to the provider. These include:

- Browser type and version
- Operating system used
- Referrer URL
- Host name of the accessing computer
- Time of the server request
- IP address

These data are not merged with other data sources. The legal basis for data processing is Art. 6 para. 1 lit. b GDPR, which permits the processing of data to fulfill a contract or pre-contractual measures.

#### **4.3. Third-Party Services and Content (Plug-ins and Tools):**

Upon visiting my website, you will be asked each time if you wish to accept cookies. You can decline, and no cookies will be stored. A selection option is displayed.

#### **4.4. Data and payment service providers**

The payment service providers Paypal or Stripe also store cookies after you have given your consent. I have no influence on the data processing of these service providers. The resulting payment information is transmitted encrypted with an SSL certificate.
